Comes Separate Defendant Laura Lynn and Counterclaimant Laura Lynn Hammett (“Lynn”), in pro se, and for her Motion for Stay of Proceedings, states as follows:

1. Laura Lynn Hammett is ill and cannot stay upright for long. Because she is self-represented, it will be difficult to generate work required.
2. There are indications that Hammett may have blood cancer or leukemia. Her immune system is compromised and her stress level is through the roof. (see the blood work from March 4, 2022 attached as exhibit A.)
3. Hammett has high neutrophils, low lymphocytes, low eosinophils, low absolute lymphocytes, a vitamin D deficiency, high bilirubin and high BUN/creatinine.
4. Hammett has not eaten solid food for over 36 hours. She drank carrot juice on the afternoon of March 4, 2022 and vomited it up.
5. Hammett has to take breaks from work after a few minutes and should probably just rest.
6. Hammett went to Legal Aid in hopes of having them represent her, and though she qualifies for the low-income assistance, they said there was a conflict of interest because they looked at the case for Micheal Pietrczak. (Legal Aid apparently decided not to file suit for Mr. Pietrczak, as did his other attorney, Billy Jack Gibson (now Judge Gibson).)

WHEREFORE, Separate Defendant Laura Lynn and Counterclaimant Laura Lynn Hammett, prays that the proceedings be stayed briefly until Hammett can sit up for extended periods and eat and drink more than a few sips of water without vomiting; and her physician verifies there is no blood cancer or leukemia.
