**REPLY IN SUPPORT OF MOTION FOR *NUNC PRO TUNC* ORDER
TO CORRECT RECORD**

Comes separate defendant, Prashanth Reddy Damalcheruvu, M.D. (“Dr. Damalcheruvu”), by and through his counsel, Anderson, Murphy & Hopkins, L.L.P., and for his reply in support of his motion for *nunc pro tunc* order to correct the record states:

1. As a threshold issue to ensure an accurate record, plaintiffs’ brief states that Dr. Damalcheruvu “order[ed] a man to be drugged, starved and dehydrated against his will[.]” *Pls.’ Brief in Support of Pls.’ Response to Def. Damalcheruvu’s Mot. to Correct the Record Nunc Pro Tunc*, p. 3. This is an inaccurate statement. Dr. Damalcheruvu is a neuro-radiologist. His alleged involvement, if any, was instead confined to the scope of his specialty as a neuro-radiologist.

2. The arguments and authorities set forth in Dr. Damalcheruvu’s motion speak for themselves.

3. Plaintiffs’ response confirms the dispositive fact underlying the motion: plaintiffs did not complete the final electronic filing step, and the documents remained in the electronic filing system as drafts rather than entering the filing queue. Plaintiffs’ intent to file the documents earlier does not constitute completed transmission.

4. Administrative Order No. 21 provides that an electronic document is filed when transmission to the electronic filing system is completed. The notice of electronic filing establishes that plaintiffs completed transmission of their response, brief, and letter on July 11, 2026, at 12:36:32.

5. Plaintiffs' arguments concerning the deadline for their response, the merits of the motion to dismiss, and Dr. Damalcheruvu's separately filed motion to strike do not alter the actual date on which transmission was completed. A *nunc pro tunc* order may make the record speak the truth, but it may not reflect that a filing occurred when it did not.

WHEREFORE, separate defendant, Prashanth Reddy Damalcheruvu, M.D., respectfully requests that the Court grant his motion and correct the record to reflect that plaintiffs' joint response, brief in support, and letter to the Court were filed on July 11, 2026, and for all other proper relief.
