A. TREMBLE (5292) TEAMED UP WITH JEREMIAH BUCKNER AND BEGAN TREATING ME WRONG BY NOT FEEDING ME, NOT ALLOWING ME TO GET MY ONE HOUR OUT SO I CAN TAKE SHOWERS AND TALK TO FAMILY. A. TREMBLE (5292) HAS TOLD ME SHE COULD GET ME AND MY KIDS HURT AND PLACING MY LIFE IN DANGER BY TELLING OTHER INMATES THAT I WAS A POLICE...
