FROM JANUARY 13 TO27, 2024, ABOUT 25 UAMS DOCTORS CONSPIRED AND FORCED A MAN, SEAN LYNN, TO INGEST CONTROLLED SUBS
TANCES, INCLUDING FENTANYL, LORAZEPAM, DIAZEPAM, HALDOL, AND PRECEDEX WITH THE INTENT TO INCAPACITATE SEAN. THEIR MO
TIVE WAS TO PREVENT SEAN'S ESCAPE FROM THE SICU. AFTER 2 WEEKS, I WAS ABLE TO PROCURE SEAN'S RELEASE AGAINST MEDICAL
ADVICE. UAMS SENT A BILL FOR OVER \$46,000. THEIR INTENT WAS TO WORK UP A 7-FIGURE BILL. NO IMMINENT THREAT OF DEATH WAS
DOCUMENTED BEFORE THE FALSE IMPRISONMENT AND BATTERY BEGAN. THE ONLY CRITERIA FOR TRAUMA ACTIVATION WAS AN ERRON
EOUS MECHANISM OF INJURY NOTED BY AN EMT WHO DID NOT WITNESS THE ACCIDENT THAT HAPPENED PRIOR TO HIS ARRIVAL ON TH
E SCENE. NO PSYCHIATRIST EXAMINED OR DIAGNOSED SEAN PRIOR TO THE DRUGGING OR FOR THE FIRST 11 DAYS OF CHEMICAL (AND
PHYSICAL) RESTRAINT. NO PETITION WAS FILED WITH ANY COURT TO OBTAIN AUTHORIZATION FOR NON-CONSENSUAL MEDICATION. SO
ME OF THE ORDERS WERE MADE BY TELEPHONE, WITHOUT THE SUPERVISING PHYSICIAN PRESENT. THE FORCED MEDICATION CONTRI
BUTED TO APHASIA AND HYPONATREMIA, NEITHER CONDITION NOTED UPON ARRIVAL IN THE ER. ALL UAMS SURVEILLANCE VIDEO OF TH
E CRIME WAS DELETED. I HAVE AMPLE EVIDENCE.
